Dear Chairperson Arnold:

The Nebraska Auditor of Public Accounts (APA) has reviewed the audit waiver request received from the Village of Sumner (Village) for the fiscal year ending 2021. **That request has been approved.**

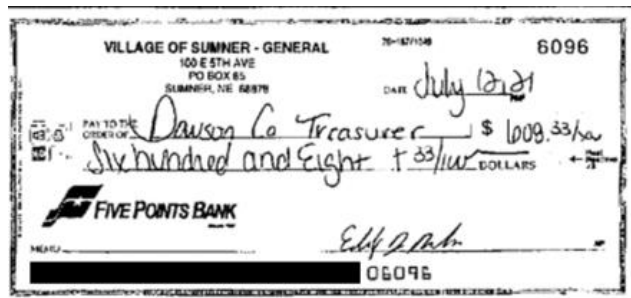
While performing, pursuant to Neb. Rev. Stat. § 84-304 (Supp. 2021), the preliminary examination necessary to determine whether the audit waiver should be allowed or further audit work would be required, the APA noted certain internal control or compliance matters, or other operational issues, within the Village.

The following information is intended to improve internal controls or result in other operational efficiencies.

Comments and Recommendations

1. Lack of Dual Signatures

The APA obtained the bank statements for the Village's accounts from its fiscal year 2021 audit waiver request. From these statements, the APA noted that 15 of the Village checks written during the examination period contained only one signature. An example of such checks is shown below.



State statute requires Village checks to be signed by both the Board Chairperson and the Village Clerk. Specifically, Neb. Rev. Stat. § 17-711 (Cum. Supp. 2020) provides the following:

All warrants drawn upon the city treasurer of a city of the second class or village treasurer must be signed by the mayor or chairperson of the village board of trustees and countersigned by the city clerk or village clerk, stating the particular fund to which the same is chargeable, the person to whom payable, and for what particular object. No money shall be otherwise paid than upon such warrants so drawn. Each warrant shall specify the amount included in the adopted budget statement for such fund upon which it is drawn and the amount already expended of such fund.

Good internal control and sound accounting practices require procedures to ensure that Village checks contain the statutorily required endorsements. Without such procedures, there is an increased risk of not only failure to comply with State statute but also the loss and/or misuse of Village funds.

A similar issue was identified by the APA in a prior review and was disclosed to the Village in the APA's letter dated February 24, 2021, which can be found on the APA's website. However, it does not appear this issue was corrected after the APA's notification.

We recommend the Board implement procedures to require dual signatures, from the Board Chairperson and the Village Clerk, on all Village checks, as required by law.

2. Lack of Claim Purpose and Amount

During our comparison of the Village's bank account details to claims approved by the Board, the APA observed meeting minutes dated January 11, 2021, and noted that the claims listed in the Board's official proceedings lacked descriptions of their respective purposes. Furthermore, one claim approved did not have the amount listed.

The following is an example of the approved claims listing provided by the Village for January 11, 2021:

Motion made to accept December to be paid in January by Irwin at 7:59 pm second Ross. Claims in the amounts of: Ravenna Sanitation \$2,233.50; Dawson County Treasurer \$608.33; Dawson Public District \$1,178.64 Frontier \$169.17; Sarah Scoville \$675.00; Dennis Triplett \$310.93; Bonnie Hanam \$13.47; Beacon Observer \$; Country Partners COOP \$1201.51; Heldt and McKeone \$; One Call Concept \$; Dennis Simmons \$; Viaero \$; Five Points Bank \$552.03; Menards \$11.88; USPS\$; Manicipal Automation and Control \$14,267.28; Ne Public Lab \$474.00; Dearbone National \$185.76; KSO CPA's \$990.00; Dan Jacobsen \$3,075.32; Central District Health \$51.00; Smith Hayes Financial \$1,320.00

Neb. Rev. Stat. § 19-1102 (Cum. Supp. 2020) requires publication of the Board's official proceedings, which must include, among other things, the purpose and amount of each claim allowed, as follows:

It shall be the duty of each city clerk or village clerk in every city or village having a population of not more than one hundred thousand inhabitants as determined by the most recent federal decennial census or the most recent revised certified count by the United States Bureau of the Census to prepare and publish the official proceedings of the city council or village board of trustees within thirty days after any meeting of the city council or village board of trustees. The publication shall be in a legal newspaper in or of general circulation in the city or village, shall set forth a statement of the proceedings of the meeting, and shall also include the amount of each claim allowed, the purpose of the claim, and the name of the claimant, except that the aggregate amount of all payroll claims may be included as one item. Between July 15 and August 15 of each year, the employee job titles and the current annual, monthly, or hourly salaries corresponding to such job titles shall be published. Each job title published shall be descriptive and indicative of the duties and functions of the position. The charge for the publication shall not exceed the rates provided for in section 23-122.

(Emphasis added.) Good internal control and sound accounting practices require procedures to ensure that the Board's official proceedings describe the purpose and amount of each claim allowed. Without such procedures, there is an increased risk of not only failure to comply with statutory publication requirements but also a lack of transparency regarding the nature of public expenditures.

We recommend the Board implement procedures to ensure the purpose and amount of each claim allowed is included in the Board's official proceedings and published in accordance with State statute.

3. Negative Bank Balance

During a review of the bank statements obtained from the Village's audit waiver request, it was noted that the Village's Street Fund account had a negative balance for seven consecutive days, the largest negative amount being \$8,159. Additionally, the Village paid \$10 in overdraft charges.

Good internal controls and sound business practices require procedures to ensure sufficient funds are available in the Village's bank accounts to pay claims.

Without such procedures, there is an increased risk for not only the loss, misuse, or theft of Village funds, but also the accumulation of overdraft fees.

We recommend the Village implement procedures to ensure sufficient funds are available in the Village's bank accounts to pay claims.
